Rental Conditions for Room Rentals

- The premises are rented only to adults.
- Only the rooms listed in the contract may be entered and used, and only during the agreed times. Failure to adhere to the times will result in a deduction of CHF 100.- from the deposit.
- **The badge and key must be collected during the week before your event, during the Open Meeting hours. At the end of your event, a closing service staff member will come; you must return the key to this person. If all rooms are in order, you will receive your deposit back.**
- **Upon handing over the key, a deposit of CHF 200.- in cash must be paid, as well as the rental fee in cash.** In case of loss of the badge/key or damage to the inventory, the costs will be charged to you.
- Cancellation fees:
 - Cancellation up to 6 weeks before the date: 30% of the rental price
 - Cancellation up to 2 weeks before the date: 60% of the rental price
 - Cancellation less than 2 weeks before the date: 100% of the rental price
- Bringing your own food and drinks is permitted. Proper disposal of waste is the tenant's responsibility. "Bebbisäcke" garbage bags must be brought by the tenant.
- Food may **only** be consumed in the **kitchen/dining room**. Kitchen utensils (including the dishwasher) are available. After use, they must be cleaned and stored in the designated place. Broken/damaged items must be reported.
- For environmental reasons, disposable tableware is prohibited at ELCH.
- Before leaving the premises: close windows and doors, turn off lights, raise blinds. The premises must be returned in a perfectly cleaned condition. Any additional cleaning required will be charged at CHF 50.- per hour.
- **Inspection of the premises takes place punctually at the end of your rental period. 15 minutes for the room inspection are free of charge. If delayed, CHF 10.- per 5 minutes will be deducted from the deposit. Leaving without waiting for the closing service results in CHF 100.- deduction.**
- Smoking is prohibited throughout the ELCH premises.
- ELCH accepts no liability for false alarms triggered via the fire alarm system. Costs (min. CHF 1500.-) that will be charged related to the "Verordnung über die von der Feuerwehr zu erhebenden Gebühren SG590.200" are fully charged to the tenant. No sparklers / fog machines etc.
- The main entrance door has an alarm triggered after 40 seconds if left open. It must remain closed at all times. Propping it open is forbidden. Resulting alarm costs are charged to the tenant.
- Animals are not allowed on the Sauter company premises or at ELCH.
- **No parking** available. Please use public parking.
- Quiet hours after 22:00. Close all street-facing windows.
- The contract signatory is fully liable for the entire premises and inventory during the rental period.
